- **American Rescue Plan Act (ARPA) Review**

- Greeley awarded \$21 Million in ARPA Funds.
- \$18 Million in available funds will be open for department application
- \$2 million minimum is committed to outside agency projects or 10% of the total.
- Budget Review going to Pre-Covid levels.
- ARPA Priority Areas
 - Building Community Resilience
 - Creating Community, Quality of Life, and Destinations
 - Enhancing Mobility
 - Activating Economic Corridors
