2. **November Minutes for approval**- see pages 4-5 of this Agenda. We did not have a quorum for the December meeting and so there are no December Minutes to approve.

6. **New Business and Action Items:**
  - a. Uptown Trees 2021-2022 – Staff and the Uptown Tree Committee are recommending three artists who each submitted a 3-D model to scale of their proposed design. The selection committee reviewed models on Dec. 2 and after all follow up questions were answered by the artist to the satisfaction of the committee the 3D models shown today are the committee's top three choices to have installed in June 2022.  
ACTION: Vote to accept the three recommended artists' proposals to be fabricated and installed along 8<sup>th</sup> Avenue for the amount of \$12,000 each.
  - b. 12 St Storm Water Outfall – The selection committee and staff recommend commissioning Adam Kuby as the final artist to work alongside the Stormwater design team to design (2022) and install (2023) artwork.  
ACTION: Vote to approve commissioning Adam Kuby to design and build artwork for the 12 St Storm Water Outfall project.
  - c. Paint the Town –
    - i. Greeley Funplex pool mural – the Selection Committee and staff recommend moving forward with an RFP to commission one or more Colorado based artists to add a mural to the inside wall of the Family Funplex pool near the 0-entry depth area. The committee recommends setting the budget at \$30,000 with \$25,000 going to the Artist this year. The artist will determine the square footage they can paint within the budget in their proposal; it is highly unlikely the entire wall will be painted now but we could extend it into a multiyear project to cover the entire wall in future years if approved. The install date will coincide with other pool renovations during the end of March and through April 2022. The theme will be family friendly, water/fun/play/sports based that will be colorful and will attract kids as well as adults.  
ACTION: Vote to approve commissioning an artist to paint a mural in the Family Funplex for \$25,000.

- ii. Stampede murals – the majority of the RAMP committee and staff are recommending that two artist be commissioned to paint murals in the two main Gate entry’s into the Island Grove Arena. The Stampede committee has requested we approve this project to add art to Island Grove, which is in our Master Plan, and help them celebrate their 100-anniversary celebration this year. They have two artists who might be interested, Armando Silva and Cody Kuehl; bot artists are skilled muralists in the area. They want a southwestern theme that speaks to the Stampede audience. The maintenance might be higher than most projects but the number of people who will view it may make it worth the cost. If approved, funds will be transferred from a current project fund that is on hold and transferred to the Paint the Town Fund; the project would then be taken to the Paint the Town committee to work out details.  
ACTION: Vote to approve requesting proposals from Armando Silva and Cody Kuehl and if approved, to commission them each paint walls of an entry Gate into the Island Grove Arena.
- d. Geometry of Flight falcons – The Ramp Committee, along with Public Art staff, unanimously recommend the purchase of a pedestal to display the existing Falcons at a new Sheepdraw Trail head on 20<sup>th</sup> Street that is located north of the crosswalk between 71<sup>st</sup> and 83<sup>rd</sup> Avenues. The budget to purchase the pedestal and install the piece at the new Trailhead is estimated to not exceed \$15,000 and if approved will be taken from the Installation and Maintenance fund.  
ACTION: Vote to approve a Budget not to exceed \$15,000 to purchase a pedestal and install the two Falcons at the Sheepdraw trailhead located on West 20<sup>th</sup> Street.
- e. 2023 Art Master Plan – please let Kim know if you are interested in assisting the RAMP committee with the development of our next Art Master Plan. We currently have four members, Dik Munson, Michelle Boreen, Eddie Mirick and Louisa Andersen on the committee. Monthly meetings will begin in January, 2022 and go through October to accomplish this important task.
- f. New or returning voting sheets for 2022 Officers will be distributed. Please complete your voting sheet and hand it to Staff. New officers will be announced at the end of the meeting. We want to thank Dik Munson for stepping up as the interim Art Commission Chair after the November change in members.

## **7. Project Reports:**

- a. Migration/Transformation new purchase - the Stained glass mosaic sculpture by Annette Coleman has been installed on the corner of 9<sup>th</sup> Ave and 8<sup>th</sup> St.; minor adjustments are needed before the purchase is final. The 'Feather' sculpture has been temporarily moved to 9<sup>th</sup> Ave and 9<sup>th</sup> St until spring when Kirk Seese picks it up.
- b. IG Trailhead Marker Art – A contract is being negotiated with botanical artist for drawings to be placed on the kiosks. A separate agreement will be offered for an artist to stamp the new trails being poured along the #3 Ditch in the Broadview Trail area.
- c. Fire Station #6 – in progress
- d. Paint the Town
  - i. New Rodarte Bus Wrap – on hold
  - ii. Excel Energy Utility Cabinets – Our point of contact is changing and we expect that to slow down the progress.

## **8. Maintenance & Repair**

- a. Peakview Park skate park 'Range' additions to design – Completed
- b. 'The History of Greeley Transportation' - Repairs to the artwork at the Transit Center have been postponed until March or April 2022.
- c. Stan is assessing the 4<sup>th</sup> Quarter (Q4) 2021 Survey Monkey artwork inspections. If you have not completed your inspections please let Stan or myself know. Q1 2022 link will be sent out by the end of January.

## **9. Other**

- a. **Tointon Gallery** – If you have not seen the Sieger Hartgers collection that is currently being displayed in the Tointon Gallery, please make time to visit. The adoption of this Collection was approved by the Art Commission, completed in 2019 and is now being displayed as the first exhibit for the re-opening of the Gallery. Feedback for this exhibit has been extremely positive.

A motion to approve the October minutes was made by Tom Devore and seconded by Eddie Mirick. The October minutes were approved unanimously.

### **New Business and Action Items:**

1. A recommendation to deaccession ‘Urban Art Deco’ Alleyway Mural by Zach Keiss was further discussed. Robb Casseday motioned to approve the second and final vote for the deaccession process. Tom DeVore seconded and the motion was unanimously approved.
2. The recommendation to purchase ‘Migration/Transformation’ by Annette Coleman with Art Acquisition funds was discussed. Sandy Magnuson motioned to approve the purchase of ‘Migration/Transformation’ for \$12,000. Rob Casseday seconded and the motion was unanimously approved.
3. A request was made for the Art Commission to consider adding new mural projects in the swimming pool area at the Greeley Family Funplex. Tom Devore motioned to approve adding new murals in the Greeley Funplex pool area in 2022. Eddie Mirick seconded and the motion was unanimously approved.

### **Project Reports:**

- b. Uptown Trees 2021-2022 –Four artists have agreed to submit a 3-D model to scale of their proposed design. Each artists will receive \$300 for completing their final submission. The selection committee will review models on Dec. 2, 2021.
- c. 12 St Storm Outfall –An RFQ has been posted to Café to solicit an artist with a deadline of November 16. .
- d. Kim begun attending meetings on the 16<sup>th</sup> St corridor project (8<sup>th</sup> Ave to 10<sup>th</sup> Ave); this project is now active again with a tentative schedule of design in 2022 and construction/ art installation in 2023.
- e. Fire Station #6 – in progress
- f. Paint the Town
- g. Excel Energy Utility Cabinets – Our point of contact is changing and we expect that to slow down the progress.
- h. IG Trailhead Marker Art – No changes
- i. New Rodarte Bus Wrap – on hold
