The vase had been broken and repaired by someone other than Public Art staff. The glue holding the pieces together have yellowed and do not represent the artist well. Tim Preston has asked that we deaccession the vase; he has offered to replace it with a new vase for our Permanent Collection. the notice to the public was posted on the Boards and Commissions Muni-code Portal beginning on April 19. No responses have been reported by the public. ACTION: second and final vote to approve deaccessioning the tall black vase by artist Tim Preston.

April 19, 2022

Meeting 4:00 PM

Art Commissioners Present – Dik Munson, Michelle Lieser-Booren, Sandy Magnuson, Tony Miller, Eddie Mirick, Tom Devore, Robb Casseday, Louisa Anderson.

Staff Present – Kim Snyder, Jason Evenson, Kelly Snook, Stan Scott, Leslie Evans.

Robb Casseday called the meeting to order.

A motion to approve the March minutes was made by Dik Munson and seconded by Tony Miller. The motion passed unanimously.

The Commission welcomed Jeff Carlson, City Planning Commission Representative, and Larry Modlin.

New Business and Action Items:

- 1. 12th St Storm Water Outfall the committee and staff shared that an additional \$59,000 had been allocated for Public Art. It was suggested that because the budget for the bid had been set prior to knowing what funding would be available; in addition to a recent meeting with the artist, Adam Kuby, and landscaper to assess the scope of the project, that the funds should be added to the existing contract. A motion to approve the project funding increase was made by Dik Munson and seconded by Sandy Magnuson. The motion passed unanimously.
- 2. Deaccession of damaged ceramic vase by Tim Preston upon reviewing a returned piece, it was determined that the tall Tim Preston vase had been damaged, then amateurly repaired. The artist has requested deaccession, as it does not represent his best work. A motion to deaccess the vase was made by Tom Devore. Louisa Anderson seconded, and the motion passed unanimously. The artist will donate a new piece.
- 3. Artwork purchases upon the recommendation of the RAMP Committee and Culture staff, a motion to approve the use of \$5500 for art purchases from the upcoming, local Arts Picnic, and from the Tointon Gallery Arts Picnic exhibit was made by Louisa Anderson. After a second from Tony Miller, the motion carried unanimously.
- 4. Arts Picnic Booth last weekend in July 30th & 31st the Commission recognized the opportunity to encourage public feedback and community connection by hosting a demo or an all-age creation station at the event. Following brief discussion, Sandy Magnuson volunteered to join further discussion with the RAMP Committee.

- a. Uptown Trees 2021-2022 We have set a tentative installation date of June 8th with the artists.
- b. Geometry of Flight falcons Stan and Joshua Bales completed the installation of the 'Peregrine Falcons' that were amended by artist AJ Davis on Friday April 8, ahead of schedule! The new pedestal is very well made, and the location is a very good fit.
- c. 2023 Art Master Plan New suggested locations for artwork from other City department project managers are being sent in for our review.
- d. IG Trailhead Marker Art In Progress.
- e. Broadview/#3 Ditch trail stamps Planning for a Spring Installation.
- f. Fire Station #6 no update
- g. Paint the Town
 - i. Greeley Funplex Mural –Julia Williams has been contracted to paint her mural in September 2022.
 - ii. Island Grove Arena Murals Armando Silva and Cody Kuehl have been contracted to paint the two main entry gates to the Island Grove Arena in May 2022.
 - iii. New Rodarte Bus Wrap on hold
 - iv. Excel Energy Utility Cabinets Our point of contact is changing, and we expect that to slow down the progress.

10. Maintenance & Repair

- a. New Graffiti removed at Balsam Park include writing on the first upright wooden structure as you enter from Balsam Ave. Also, the stone 'bear cave' installed by Parks that Wes added art designs to was tagged with spray paint and it had to be removed. Repairs are also needed to the concrete painting under the shelter; Wes will make amends when he is here in June and the weather is warmer.
- b. 'The History of Greeley Transportation'
 - i. Artist Kirk Seese was in Greeley to assess the damage to the artwork at the Transit Center in May; he will return in June to do the repairs.
 - ii. The artwork also sustained damage from high winds during April. This damage does not fall under the artist's warranty; Stan will work on getting the artwork repaired.
- **c.** Q1 2022 Survey Monkey art inspections should be completed soon if not done already. Stan will have an updated report of pieces that need to be looked at the May 17 GAC meeting. Please let Stan know if you have guestions.
