1. **Repairs** (unexpected damages)
 - a. New and ongoing repairs
 - i. New graffiti found at 3rd Street and Centennial Skateparks. Scott is working with the graffiti removal team to remove graffiti from core ten sculptures.
 - ii. Peakview Skatepark – cover was removed and replaced by unknown person.
 - iii. Damage to ‘Dragonfly Giraffe’ — the red propellor element was found on the ground and reported by a citizen walking the trail. John King has removed the top portion of the sculpture and will make repairs in his studio before returning to reinstall it.
2. **Acquisitions** (Donations, Direct Purchase, deaccessions)
 - a. Discussion – Age and condition of ‘Red Violin’ UNC student art that was donated to the City in 2015 by the Greeley Philharmonic Orchestra.
