4. **Public Comment – N/A**
5. **New Business and Action Items:**
 - a. 12th St Storm Water Outfall – Adam Kuby met with staff on Friday April 8th to see the site, get an overview of the project and to discuss art possibilities with the landscaper. He will be forming his ideas to integrate artwork into the project over the next few months. The budget for this project was set before we knew how much actual 1% funding would be generated from Phases 1A & 1B/holding pond with outfall to the river in. We currently have the artist contracted for \$25,000 for artist design and \$55,000 for artwork. We learned this year that an additional \$59,000 has been allocated for 1% for Art in. The committee and staff are recommending we add \$45,000 in additional funds to the existing contract for artwork, and the remaining for administrative costs i.e.: project management, contingency etc. **ACTION: vote to approve the increase of \$59,000 for the project with \$45,000 of that added to the artist contract for the 12th St Outfall stormwater project.**
 - b. Deaccession of damaged ceramic vase by Tim Preston – The RAMP committee and Staff recommend deaccessioning the tall Tim Preston vase. The vase came back to us this year showing that it had been broken and repaired by someone other than Public Art staff. The glue holding the pieces together have yellowed and do not represent the artist well. Tim Preston has asked that we deaccession the vase; he has offered to replace it with a new vase for our Permanent Collection. **ACTION: vote to approve deaccessioning the tall black vase by artist Tim Preston.**
 - c. Artwork purchases – The Ramp committee and Culture staff recommend making purchases each year at the July Arts Picnic in the Park and the Arts Picnic exhibit in the gallery with the Art Acquisition funds. This is a way to support out local artists as well as all who come to Greeley in July. **ACTION: vote to approve up to \$5000 for art purchases from both Arts Picnic events to add to our Permanent Art Collection.**
 - d. Arts Picnic Booth last weekend in July 30th & 31st – Is the Art Commission interested in hosting a booth in 2022 and are there suggestions for changes? **DISCUSSION ONLY**

6. Project Reports:

- a. Uptown Trees 2021-2022 – We have set a tentative installation date of June 8th with the artists.
- b. Geometry of Flight falcons – Stan and Joshua Bales completed the installation of the ‘Peregrine Falcons’ that were amended by artist AJ Davis on Friday April 8, ahead of schedule! The new pedestal is very well made, and the location is a very good fit.
- c. 2023 Art Master Plan – New suggested locations for artwork from other City department project managers are being sent in for our review.
- d. IG Trailhead Marker Art – In Progress.
- e. Broadview/#3 Ditch trail stamps – Planning for a Spring Installation.
- f. Fire Station #6 – no update
- g. Paint the Town
 - i. Greeley Funplex Mural –Julia Williams has been contracted to paint her mural in September 2022.
 - ii. Island Grove Arena Murals – Armando Silva and Cody Kuehl have been contracted to paint the two main entry gates to the Island Grove Arena in May 2022.
 - iii. New Rodarte Bus Wrap – on hold
 - iv. Excel Energy Utility Cabinets – Our point of contact is changing, and we expect that to slow down the progress.

7. Maintenance & Repair

- a. New Graffiti removed at Balsam Park include writing on the first upright wooden structure as you enter from Balsam Ave. Also the stone ‘bear cave’ installed by Parks that Wes added art designs to was tagged with spray paint and it had to be removed. Repairs are also needed to the concrete painting under the shelter; Wes will make amends when he is here in June and the weather is warmer.
- b. ‘The History of Greeley Transportation’ –
 - i. Artist Kirk Seese was in Greeley to assess the damage to the artwork at the Transit Center in May; he will return in June to do the repairs.
 - ii. The artwork also sustained damage from high winds during April. This damage does not fall under the artist’s warranty; Stan will work on getting the artwork repaired.
- c. Q1 2022 Survey Monkey art inspections should be completed soon if not done already. Stan will have an updated report of pieces that need to be looked at the May 17 GAC meeting. Please let Stan know if you have questions.

8. Other

- a. The on loan ‘Feather’ by Kirk Seese was removed from downtown
- b. Large art donation that includes over 30 Japanese pottery pieces and many 2-D wall pieces is in progress of being collected and documented.
- c. **Tointon Gallery** – Current Exhibit: Ariels by Barbara Baer and MA Guthrie. The show will be up through April 31st.

Greeley Art Commission Minutes

March 15, 2022

Meeting 4:00 PM

Art Commissioners Present – Michelle Lieser-Booren, Danyelle Butler, Sandy Magnuson, Tony Miller, Dominic Anaya, Eddie Mirick.

Staff Present – Kim Snyder, Jason Evenson, Leslie Evans.

The board unanimously appointed Sandy Magnuson chair pro-tempore due to Dik Munson's and Robb Casseday's absence.

Sandy Magnuson called the meeting to order.

A motion to approve the January minutes was made by Danyelle Butler and seconded by Tony Miller. The motion passed unanimously. There were no minutes for February, as the meeting was cancelled.

New Business and Action Items:

1. Paint the Town
 - a. Greeley FunPlex Mural – the committee, along with the CPRD staff, have selected an artist to paint the new pool mural. The committee has previously approved a budget of \$25,000.00 and is planning the installation for September, while the pool is undergoing maintenance. A motion to approve the artist was made by Tony Miller. It was seconded by Danyelle Butler and passed unanimously.
 - b. Island Grove Arena Murals – the committee, Culture staff, and Stampede put forward designs by Armando Silva and Cody Kuehl for the main entry gates at Island Grove Arena. Eddie Mirick moved to approve the preliminary designs. Tony Miller seconded, and the motion carried unanimously.
2. CPRD Memorial Policy – the board reviewed the newly adopted memorial policy. Jason Evenson explained that the policy was adopted for organization continuity.
3. CPRD Naming Policy - the board reviewed the newly adopted naming policy. Following review, Tony Miller raised the concern regarding naming for living people. Jason Evenson confirmed that current parks were named posthumously.

9. Project Reports:

- a. Uptown Trees 2021-2022 – two artists have been contracted; Ana Marie Botero and Kiki Gotit to install in June 2022. The third artist, Kristin DeSantis has let us know she cannot complete the proposed sculptured as planned.
- b. 12th St Storm Water Outfall – Adam Koby has been contracted and has begun meeting this month with the Stormwater committee that includes contractors and Culture staff.
- c. Geometry of Flight falcons – Stan and Kim are actively working to with Joshua Bales to create a concrete foundation and a metal pedestal that will display the Falcons. Josh presented costs for both Corten and mild steel with a patina; Josh recommends the mild steel at a cost savings of approximately \$1000. The total contract is for \$13,500, within the approved budget; staff are moving forward with the contract for mild steel fabrication. Dates for installation will be scheduled for May/June 2022.
- d. 2023 Art Master Plan – In progress
- e. IG Trailhead Marker Art – Marjorie Leggitt has been contracted to provide botanical drawings to be placed on the informative Trailhead Kiosk.
- f. Broadview/#3 Ditch trail stamps – Ambrette Gilkey has been contracted and will begin work this spring when the concrete trail is being poured.
- g. Fire Station #6 – no update
- h. Paint the Town
 - i. New Rodarte Bus Wrap – on hold
 - ii. Excel Energy Utility Cabinets – Our point of contact is changing, and we expect that to slow down the progress.

10. Maintenance & Repair

- a. Big To-Do Memorial – one marble panel is cracked but may not need to be replaced. Kim will do further research.
- b. 'The History of Greeley Transportation' - Repairs to the artwork at the Transit Center are planned for March 30.

11. Other
