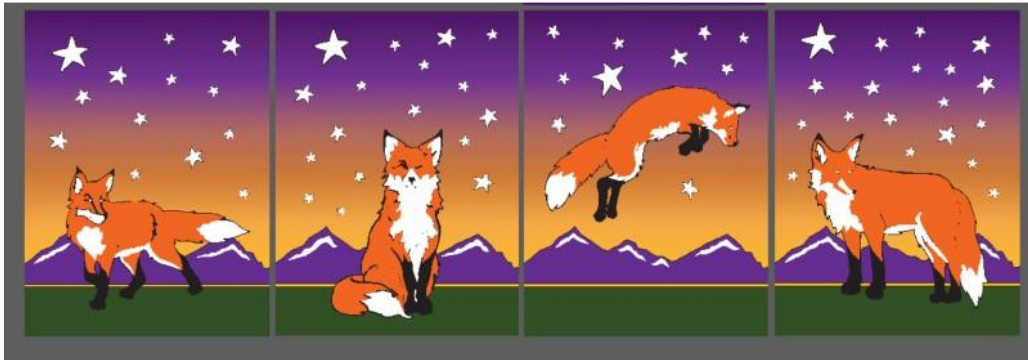

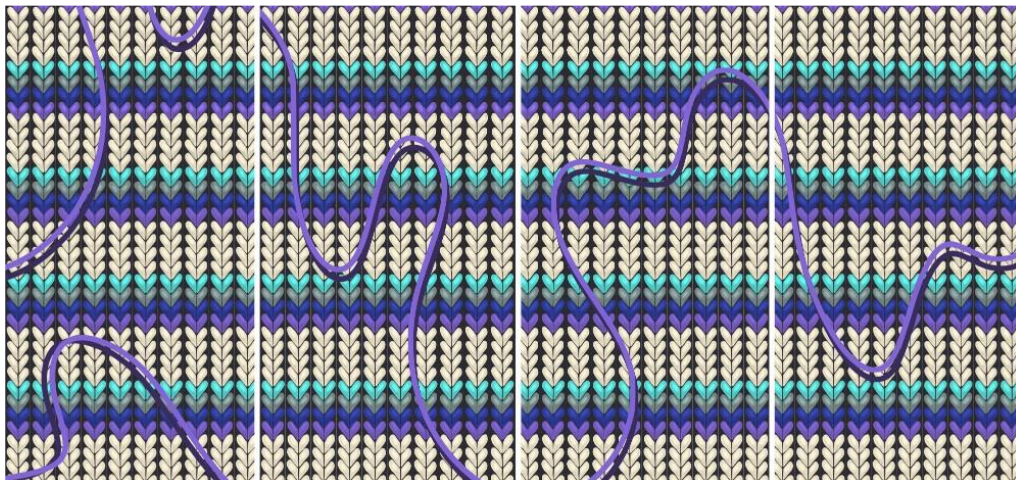

Meeting was called to order at 4:00 p.m.

A motion to approve the November minutes was made by Eddie Mirick and seconded by Tom Devore. The motion passed unanimously.

Introductions were made for the new Parks & Rec rep, Sharon Wilson.

New Business and Action Items:

- a. Uptown Trees – the Selection committee including 2 Art Commissioners, reps from the DDA, LINC Library and Resort 55 recommended that five finalists be invited to the final round by sending in a 3-D model in a 1:1 scale of the piece they are submitting. The three locations for new trees are: the SE corner of LINC library, SE corner of 8th Ave & 11th St and NE corner of 8th Ave & 12th St. Tom Devore moved to approve advancing all five of the artists shown today to the final round and for each approved artist to be reimbursed \$300 for their time, materials, and shipping. Eddie seconded the motion. The vote to approve was unanimous.
- b. 2023 Officers discussion –Kim requested names of current members who are willing and able to fill the office of Chair or Vice Chair for the Art Commission next year.
