**6. Project Reports:**

- a. 2023 Uptown Trees – All artists have been contracted and are ready to begin fabricating. The three locations we intend to add trees to are the SE corner of LINC library, SE corner of 8<sup>th</sup> Ave & 11<sup>th</sup> St and NE corner of 8<sup>th</sup> Ave & 12<sup>th</sup> St. One alternate has been released.
- b. 12th St Outfall Art – Overall project has been slowed down. Adam Kuby is expecting a 2024 installation and will present his final design to the GAC in April 2023.
- c. Coloring Book Update – Coloring Books are at the printer and will soon be distributed.
- d. Broadview/#3 Ditch trail stamps – the final portion of the Trail has been stamped with badger prints.
- e. Fire Station #6 – progress continues. We will expect an April installation with a dedication ceremony Thursday April 13<sup>th</sup> 3-6pm.

A motion to approve the January 24 2022 minutes was made by Tom Devore and seconded by Tony Miller. The motion passed unanimously.

**9. New Business and Action Items:**

- a. 2023 Uptown Trees – The committee is recommended three finalists be contracted \$12,500 each to fabricate and install sculptures shown by the 3D models of the sculptures presented today. One alternate has also been recommended.  
After discussion, Sandy Magnuson moved to approve all three artists and one alternate sculptural designs presented today for the Uptown Tree installations in August/September 2023. Tony Miller seconded the motion. The motion passed unanimously.
- b. Traffic Cabinets –One artist, Chloe Kummerfeld attends Union Colony School and we have Streets approval to place her art wrap design on the traffic cab by the school crosswalk. The GAC committee members recommend this placement. Robb Casseday moved to approve placing the design by Chloe Kummerfeld on the traffic cab at 20<sup>th</sup> St; Tom Devore seconded the motion. The motion was passed unanimously.
