 - a. Thank you to Sandy for presenting the 2023 Coloring Books at the March D6 Board meeting.
 - b. Delta Park – Clint Anders to discuss new Delta Park designs and request funding for an art piece. Staff suggests contributing 50,000 for Art next year, that may come with some added funds.
ACTION - Vote to approve adding a Delta Park project for \$50,000 in 2024.
 - c. 16th St. Renovations Art – the Committee including Art Commission, City planners, UNC staff and citizens recommend Mario Miguel Echevarria to join the overall project design team to add artwork to the 4-block area.

- a. 2023 Uptown Trees – All artists have been contracted and are ready to begin fabricating. The three locations we intend to add trees to are the SE corner of LINC library, SE corner of 8th Ave & 11th St and NE corner of 8th Ave & 12th St. One alternative has been released.

Meeting was called to order at 4:00 p.m.

A motion to approve the February 21, 2023, minutes was made by Tony Miller and seconded by Tom Devore. The motion passed unanimously.

9. New Business and Action Items:

- a. Guest Speaker - Ed Rogers presented an Arts Legacy proposal to install three granite Steles in front of the UCCC. After Q & A, Sharon moved to approve the affirmation of the Art Commission as a stakeholder to placing three Steles on the east side of the UCCC near the sidewalk. Sandy seconded the motion. The motion passed unanimously. The Art Commission will follow suit with a letter drafted by the UCCC Board and will sign and make it available to the Arts Legacy.
- b. 16th St. Renovations Art – the vote to approve one artist for Art Installations has been tabled until the April meeting in because one additional round of jury needs to be conducted.
- c. Paint the Town – the Art Commission has been requested to approve wrapping the slide enclosure at the Discovery Bay pool for approximately \$8,000. If approved, this will be added to the existing Raven Signs contract to wrap five Traffic Cabinets in 2023. Sandy moved to approve the project to wrap the slide enclosure metal panels with a new artist designs; Tom seconded. The motion passed unanimously.
- d. Meeker House possible changes to design – Previous agreement was made by the Art Commission to add an Art fence around the Meeker Home when other Museum renovations are conducted. Further discussion was had asking the Commission to broaden the scope of the work and not to be limited by an art fence. The recommendation by Museum staff is to include art that Native American groups in the area feel will represent a larger picture of the history of the Meeker Home. A unanimous consensus was made to broaden the scope and not limit it to an Art Fence.
