5. **New Business and Action Items:**
  - a. The RAMP committee is recommending that we consider adding a new mural project if the details yet to come are accepted by all. Bianca Fisher, DDA, is interested in contracting with Armando Silva to paint a new mural on a downtown wall. after doing proper research, she has concluded that we can use the "Howdy from Greeley" mural image without licensing or fees. It is proposed for the wall at 1221 8th Ave. DDA is curious to see if the Arts Commission would want to partner on the project. We don't know the cost yet, but the RAMP committee would be willing to commit around \$15,000. We think it would be a great addition in a highly visible location. Consensus requested to move forward.
  - b. Uptown Trees - Approve Jeff Wise requested changes
  - c. The City of Greeley City Clerk's Office, with the assistance of hrQ – a local management consulting firm that has completed other work with the City, is working on an update to the City's recruitment, onboarding, and orientation processes for the City Council appointed Boards and Commissions. The ongoing City Council initiative is set up to collect data intended to increase public participation and engagement. One objective of this project includes identifying ways to maximize recruitment of board and commission members and engagement with the public. While the City Council is requesting additional feedback regarding meeting times, be assured that individual meeting times for Boards and Commissions are within the discretion of each respective Board and Commission. No formal action is required of any Board or Commission to adjust meeting times or format at this time – if the consensus is to do so, that action may occur at this, or a future meeting determined by the Board or Commission. With that, we are asking that each board discuss and consider the following options and reach consensus with a report back to the City Clerk's Office:
    - i. Discussion of interest in moving meeting times that are currently held between the hours of 9 a.m. - 5 p.m. to a time that is before 9 a.m. or after 5 p.m. to maximize public participation.
    - ii. Discussion of interest in expanding meeting forms to maximize public access such as virtual meetings, in-person meetings, or hybrid meeting options.

- a. 2023 Uptown Trees – all trees are in the fabrication phase and on schedule. An Installation dates has been tentatively scheduled for Tuesday August 8<sup>th</sup>. The three locations we intend to add trees to are the SE corner of LINC library, SE corner of 8<sup>th</sup> Ave & 11<sup>th</sup> St and NE corner of 8<sup>th</sup> Ave & 12<sup>th</sup> St. One alternative has been released.
- b. 16<sup>th</sup> St. Renovations Art – Mario Miguel Echevarria has been contracted and has begun working with the design team.
- c. Longview Park – We are looking at an August/September installation.
- d. Traffic Cabinet Art Wraps – All artist designs have been submitted and will be installed by Raven Signs as weather allows.
