After School Program- 2020=65 and 2021=123 (+58) low daily attendance since first of December (average is 51 for December)

Anna Gimmestad-37 registered youth

-New programming for Social Emotional Learning starting in the spring semester. We have taken on an Intern that is studying Psychology to focus on our mindfulness, health and wellness program. She will be in charge of the Power Up for Life curriculum and

implantation.

-COVID: CMO has required all staff to wear a mask, but patrons and participants are not required. A letter was sent home to all parents last Tuesday letting them know that we no longer will require masks. We had to close Anna Gimmestad due to a participant testing positive for COVID and being in the facility yesterday, while not wearing a mask. -Focusing on professional development for part time and full time employees. Part time employees were trained on Suicide Education and Awareness. They received their certificate in QPR, which is question, persuade and refer through Northrange Behavioral Health. Full time employees worked on critical prioritization tools and methods through mindtools.com for December.
